

# Congratulations, CLASS OF 2024

St. Pius X Catholic High School recently graduated 67 students in its 2024 class. 97% of the class will be enrolling in college in the fall or enlisting in the military. 63 students will be attending 26 different colleges in 8 states, with 2 seniors enlisting in the Army National Guard.



- Accepted at 62 colleges in 20 states
- 15 (22%) attending a two-year / technical college
- 48 (72%) attending a four-year college / university
- 2 (3%) have enlisted in the Army National Guard
- 48 students earned \$1.76 million in accepted merit / talent scholarships
- Class grade point average: 3.59
- 25 students graduated with a 4.0 or above GPA
  Top GPA is a 4.339 / 4.5
- ACT Composite average for the Class of 2024 is 22.6
  - The top 10% of the class: 30.5 ACT composite
  - The top 25% of the class: 27.6 ACT composite
  - The top 50% of the class: 24.9 ACT composite
  - The national ACT average is 19.5



It has been an exciting 2023-24 school year regarding our 583 Program. Our innovative 583 program is our college visit initiative in which we take 5 college trips to 8 different schools in a student's first 3 years of high school. This school year, our juniors took trips to Southeast Missouri State University, Missouri Baptist University, and the University of Missouri at St. Louis (UMSL). Our sophomores took visits to Saint Louis University, McKendree University, Maryville University, and Lindenwood University. Our freshman students began their 583 journey this year by taking a trip to Jefferson College in the spring.

Recently, we have introduced a new element to our 583 program as we have identified students that are interested in the trades or a technical school and look to explore places of interest in those areas.

In February, we took a group of students to tour Good Earth Tools and to Jefferson College to get an in-depth look at some technical programs. In the spring, we took a group of 18 students to a regional event called "Build My Future STL" where students engaged in hands-on construction activities. We look forward to continuing to give our students opportunities to visit four year universities, two vear colleges/technical schools, and local industry to explore as many post-secondary options as possible.




### SAMANTHA GOLDSMITH CLASS OF 2015
